Training overview

The training offer proposes 6 certifying paths, each one composed of several training courses.

The duration of a course (or "module") varies between 4 hours and 3 days. Each module focuses on specific learning objectives as well as on a precise level of understanding.

To obtain a certification a candidate has to pass all the examinations of the certificate **UCIs Fundamentals Certificate** as well as of the chosen certified path.

Candidates who wish to obtain a global certification in addition to a particular career certification can select a number of courses out of the **Senior Fund Specialist** offer.

Courses in detail

01 Certified Path **FI018PC** **UCIs FUNDAMENTALS CERTIFICATE**

Prerequisites: None

The Fundamentals Certificate is a prerequisite for all of the certifications in this House of Training / ALFI training offer and provides a fundamental knowledge of the legal, regulatory and ethical context of the investment fund industry in Luxembourg as well as the fundamentals of the classic underlying financial instruments and the standard operational flows.

People wishing to obtain this certification, who are able to provide a recognized examination certificate proving that they have the required knowledge in the financial products subjects, may request possible exemptions.

Target Audience

This certified path targets a broad audience, i.e. anyone wishing to acquire a fundamental knowledge in the investment fund industry in Luxembourg.

This certified path is composed of a number of training courses which are offered in French and/ or in English.

02 Certified Path **FI019PC** UCIs FUND ACCOUNTANT (JUNIOR)

Prerequisites: UCIs Fundamentals Certificate

Setting up an investment fund: The fund accountant books all the transactions and the operations having an impact on the assets of a fund. His / her role also includes the valuation of funds in order to determine their net asset value and to prepare financial statements.

People wishing to obtain this certification, who are able to provide a recognized examination certificate proving that they have the required knowledge in any of the financial products subjects, may request possible exemptions.

The UCIs Fund Accountant career path is split into two certificates "Junior" and "Senior".

Target Audience

This certified path targets fund industry professionals wishing to develop their career as a fund accountant.

TRANSFER AGENT

Prerequisites: UCIs Fundamentals Certificate

Setting up an investment fund: The transfer agent is the intermediary between investors, distributors and the investment fund. Transfer agency professionals handle subscriptions, redemptions, switches and manage cash. They manage investor documentation whilst performing the necessary controls required within the regulatory framework of anti money laundering and watch over fund events related to the funds' portfolios.

Target Audience

This certified path targets fund industry professionals wishing to develop their career within a transfer agency.

Setting up an investment fund: Custodian and depositary bank professionals are tasked with the monitoring of investments and ensuring the availability of the assets of the funds. They ensure that investments are made in conformity with the policies and restrictions of the funds and manage the corporate actions of the shares that the funds are invested in.

People wishing to obtain this certification, who are able to provide a recognized examination certificate proving that they have the required knowledge in any of the financial products subjects, may request possible exemptions.

Target Audience

This certified path targets fund industry professionals wishing to develop their career within a depositary or custodian bank.

SENIOR FUND SPECIALIST

For those seeking a more versatile and transversal qualification in funds, not just specializing in one particular domain, the House of Training also offers a more comprehensive certificate for which the eligibility criteria are indicated below. Alongside traditional funds, this certificate also includes a fundamental knowledge of alternative investment funds (Real Estate, Private Equity and Hedge funds).

Due to the constant evolution of the fund industry, the composition of this certification has been regularly updated. Upon request, candidates having worked towards this certification over an extended period and based upon previous requirements, may also be considered for eligibility.
